#### **Minutes of the Benefits Committee**

November 19, 2015

With a quorum of the committee present, the meeting convened at 3:02 p.m.

## 1. Consider the approval of the proposed minutes of the October 22, 2015 committee meeting – Committee Chair.

On a motion by Ms. Sissney, seconded by Ms. Ramirez, the committee unanimously approved the proposed minutes of the October 22, 2015 committee meeting, as presented.

## 2. Receive an update on issues impacting open enrollment in TRS-ActiveCare – Mike Nelson, Aetna.

Mr. Nelson provided an update on TRS-ActiveCare enrollment issues during the recent active open enrollment period. He apologized for the disruption caused to the administration of the plan. He described organizational changes that had occurred within WellSystems, Aetna's sub-contractor handling the enrollment filing process.

Mr. Greg Wood of Aetna described Aetna's service recovery plan. He discussed key challenges as well as service enhancements that were implemented to address the challenges and root cause of current issues. He described changes Aetna was requiring of WellSystems regarding quality improvement, including improving customer service, quality protocols, and human resources. He also described changes needed for reporting, technology, process and control, and better collaboration with third-party administrators (TPAs).

Mr. Guthrie expressed his concerns regarding the worsening of the situation reported to the board by the representatives of the affected districts. He asked the Aetna representatives how long the problems may persist. Mr. Wood stated that Aetna had been aggressively working with the Fort Worth district and their TPA each week and would continue to work with the districts on a proactive basis to address their concerns. Mr. Guthrie asked what proactive measures Aetna was taking to address those concerns. Mr. Magliano stated that Aetna had taken steps to directly improve WellSystems' operations, including implementing a new service model and overseeing WellSystems. He confirmed for Mr. Guthrie that Aetna would provide TRS a complete list of the affected districts

Per Ms. Palmer's request, Mr. Lamendola, WellSystems CEO, addressed the committee. He discussed plans to resolve the issues with Aetna. Mr. Kelly stated that he would like to know what remediation actions, such as training and reprocessing, had been taken. He encouraged board members to seriously consider putting the contract out for bid. Mr. Lamendola admitted that the level of service was unacceptable and stated that he was committed to providing the expected level of services and to eliminating the problems. Mr. Guthrie noted that the decision of whether to issue a new solicitation would depend on the resolution of other issues such as delivery model, cost metrics, and sustainability. He asked Aetna to provide mitigating factors. Mr. Nelson stated that Aetna had promised to better control costs than before, and he guaranteed that there would be zero cost increases. He stated that all the claims at issue should be considered complete by March 2016 and that early results had been positive. Ms. Imig described the data review process. Further discussion followed regarding documenting Aetna's member satisfaction, Aetna's contract performance, and comparisons with previous contracted health plan administrators.

Ms. Palmer announced that the committee would go into executive session on agenda item 2 under section 551.071 of the Government Code to seek advice from legal counsel. She asked all members of the public and staff not needed for the executive session to leave the meeting room and take their belongings with them.

Whereupon, at 3:45 p.m., the committee went into executive session.

At 5:09 p.m., Ms. Palmer announced that the committee had reconvened in open session. She opened the floor for further discussion on the agenda item. Mr. Moss suggested that the committee recommend that the board call a meeting in the Dallas area on December 7, 2015 to discuss next steps to resolve the issues. On a motion by Mr. Moss, seconded by Ms. Ramirez, the committee unanimously voted to recommend to the board that a special meeting be conducted on December 7, 2015 to further discuss the contract with Aetna and other related matters.

## 3. Discuss and consider recommending to the Board appointments to the Retirees Advisory Committee – Katrina Daniel.

Ms. Daniel described the background and function of the Retirees Advisory Committee (RAC). She stated that the terms of four committee members would expire on January 31, 2016, including the positions of:

- Active teacher,
- Active member of the auxiliary personnel of a school district,
- Retired teacher, and
- Retired school administrator.

She stated that in addition, there were three vacancies to be filled, including the positions of:

- Active teacher,
- Active school administrator, and
- Retired member of the auxiliary personnel of a school district.

She presented staff's recommendation on each position. The committee conducted a voice vote on each nominee for each position and selected the nominee(s) who received the most votes.

The committee voted to recommend that the board appoint Dr. Celeste Cardenas and Teresa Koehler to the two Active Teacher positions, Grace Mueller to the Retired Teacher position, Dr. John Fuller to the Retired School Administrator position, Dr. Bruce Gearing to the School Administrator position, and Jesus Soto to the Retired Auxiliary Personnel position.

For the Active Auxiliary Personnel position, Ms. Palmer stated that no nominee had been recommended. She stated that future applications for the position can be submitted to Ms. Daniel.

4. Consider making a recommendation to the Board regarding the existing contract between TRS and Genworth Life Insurance Company, the carrier authorized by TRS to provide group long-term insurance under Chapter 1576 of the Texas Insurance Code – Katrina Daniel and Edward Esquivel.

Ms. Daniel stated that TRS had a six-year contract ending August 2015 with Genworth to provide group long-term care insurance. She explained that the contract was automatically renewed each year upon receipt of the annual premium. She presented staff's recommendation to extend the

contract through August 31, 2016. She provided an update on coverage, including program enrollment, underwriting standards, and changes in costs and benefits. Mr. Esquivel explained the premium variance based on a participant's age. Ms. Daniel reported that the program had about 7,200 enrollees.

On a motion by Mr. Ramirez, seconded by Ms. Sissney, the committee voted unanimously to recommend that the board adopt the proposed resolution ratifying the extension of the contract between TRS and Genworth Life Insurance Company for one year, as recommended by staff.

The meeting adjourned at 5:38 p.m.

**Subject:** TRS-Care Retirees Advisory Committee Nomination / Vacancy / Active Member

**Auxiliary Personnel Position** 

TRS has received two eligible nominations for a position on the Retirees Advisory Committee (RAC). These nominations are for the position of "active member of the auxiliary personnel of a school district." During its April 2016 meetings, the TRS Benefits Committee and Board of Trustees are scheduled to consider the possible appointment of one of these candidates.

Subchapter I of Chapter 1575 of the Insurance Code establishes a nine-member RAC appointed by the Board of Trustees. The law specifies that the RAC will have the following members:

- One member who is an active school administrator;
- One member who is a retired school administrator;
- Two members who are active teachers;
- Three members who are retired teachers;
- One member who is an active member of the auxiliary personnel of a school district; and
- One member who is a retired member of the auxiliary personnel of a school district.

The duties of the committee as outlined in Subchapter I of Chapter 1575 are to:

- Hold public hearings on group coverage;
- Recommend to the trustee minimum standards and features of a plan under the group program that the committee considers appropriate; and
- Recommend to the trustee desirable changes in rules and legislation affecting the group program.

State law also provides that the members of the RAC shall serve staggered four-year terms. The position below has been vacant since May 21, 2014, and this term will expire January 31, 2020:

• One active member of the auxiliary personnel of a school district (which includes bus drivers, cafeteria workers, custodians, and administrative staff).

TRS staff has evaluated the nominees, Ms. Andrea Avery and Ms. Sheri Vaughn, based on the following criteria:

- Member of the auxiliary personnel of a school district
- Length of experience as a TRS member and/or retiree
- Participation in education-related volunteer programs
- Professional activities and experience serving on committees, boards, or decision-making organizations, especially related to healthcare benefits or other benefits
- Credentials, awards, or other meritorious recognition
- Geographic diversity compared to other RAC members
- Experience in the field of healthcare benefits or a related field

Please consider the information contained in the enclosed "Candidate Nomination Summary" in applying the above listed qualifications for this position on the RAC.

TRS staff would be happy to assist you with further analysis of the candidates. Thank you for your consideration in this matter.

### **M**EMORANDUM

**SUBJECT:** Medical Board Member

Government Code Section 825.204 states that the Board of Trustees shall appoint a Medical Board composed of three physicians. The TRS Medical Board (board) is composed of three licensed physicians and is charged with determining whether TRS members who apply for disability retirement benefits meet the statutory requirements to receive such benefits. Specifically, members of the board must determine whether a member is mentally or physically disabled from the further performance of duty and whether the disability is probably permanent. The term of one of the current members expires on August 31, 2016. He has served on the board since January 1995 and is currently the chair.

Board members must be physicians licensed to practice medicine in Texas and be in good standing in the medical profession. The position requires review of TRS member applications for disability retirement and supportive documentation provided by the member and the member's physician(s). The majority of TRS disability retirements are related to: neurological; metabolic; neoplastic; psychological; cardiovascular; degenerative joint diseases; or back problems. Board members must be experienced in these areas and in rendering decisions concerning disability. Approximately 1,000 disability applications are filed annually. The board meets every other month to discuss disability retirement applications and other related issues. In the past members were appointed for a six year term. Based on the new Board Procurement Policy it can be no more than five years. The last reappointment has a term of three years. Board members are paid \$36,630 annually for services performed.

There are two options available for filling the board position that will be vacated by Dr. Larry Wilson at the end of August. The Board can choose to reappoint Dr. Wilson for an additional three year or five years or the position can be advertised and filled by an applicant.

The process for advertising and filling the board member position involves soliciting applications through the Texas Medical Association magazine. Interested physicians are required to send a cover letter and resume that highlights their experience required to serve on the board. Applicants that meet the requirements for the position and are in good standing in their profession will be interviewed for the position. This process will take approximately three months. During the July 2016 meeting a recommendation will be presented to you for your approval. Upon your approval the appointment becomes effective on September 1, 2016.

TRS disability retirement statutory requirements and experience requirements make it challenging to fill these positions. Since Dr. Wilson continues to do an excellent job serving on the board, is currently the chair and is willing to continue serving, staff recommends that we move in the direction of reappointing Dr. Wilson for an additional three year or five years beginning on September 1, 2016. If the Committee agrees, we would bring this back in June for the official resolution for reappointment. If the Committee does not agree with staff we will proceed the procurement process for advertising the Medical Board vacant position.
