MyTRS provides members and retirees
24/7 access to their personal information.



MyTRS is the secure online access portion of the TRS website where you can view your current account information, obtain retirement estimates, sign up for e-mail subscriptions, print copies of important documents such as your statement of account or 1099-R form, and much more.



How do you register for *MyTRS*?

1. On the homepage of the TRS website (www.trs.state.tx.us), click on the “*MyTRS* LOGIN” button.
2. Select the “Register Now” link.
3. Read the instructions and accept the *MyTRS* Security Agreement.
4. Enter the information requested.
5. Create your own unique User ID and password. This will be the User ID and password you will use for future visits to *MyTRS*. Please keep your password private as anyone who knows your User ID and password can access your personal information.
6. Follow the remaining instructions to complete the registration process.

NOTE: *Please allow one business day after registering for MyTRS to view and print TRS forms specific to your account.*

As an active member, once you have a *MyTRS* User ID and password, you can do the following things on the TRS website:


- View your personal information
- View your most recent TRS annual statement
- View your current account balance
- Estimate your retirement benefits using your current account information on file with TRS
- Register for a group benefit presentation
- Choose *MyTRS* E-mail Subscriptions for selected TRS publications, TRS announcements and notification of legislative changes
- View and print any existing unpaid service credit purchase bills you may have, such as: Bill for Withdrawn Account, Bill for Unreported Deposits, Bill for Military Service Credit, and Bill for Out of State Service Credit. Additionally, view and print an installment agreement and rollover form for these bills.
- If you are already purchasing special service on monthly installments, view and print a Statement of Payments Received.
- Update and maintain your contact information (mailing address, e-mail address and telephone number)
- Update or change your security information (the User ID, password, or security questions created during the *MyTRS* registration process).

As a retiree and/or beneficiary receiving an annuity payment, once you have a *MyTRS* User ID and password, you can do the following things on the TRS website:

- View your personal information
- View your most recent 1099-R form(s)
- View verification of your monthly annuities, including verification of raise amounts, and verification of DROP payment amounts, if applicable
- View your current income tax withholding choices and calculate the effect of changes to those choices
- View your Annual Health Benefit Premium Deduction
- Choose *MyTRS* E-mail Subscriptions for selected TRS publications, TRS announcements and notification of legislative changes
- Update and maintain your contact information (mailing address, e-mail address and telephone number)
- Update or change your security information (the User ID, password, or security questions created during the *MyTRS* registration process)

Note: You may print anything that is available for you to view.

If you have been unsuccessful in registering for *MyTRS*, it may be because you are no longer a TRS participant. If you have terminated your account by withdrawing your contributions or you are no longer receiving a monthly annuity payment, you will not be able to register for *MyTRS*.
