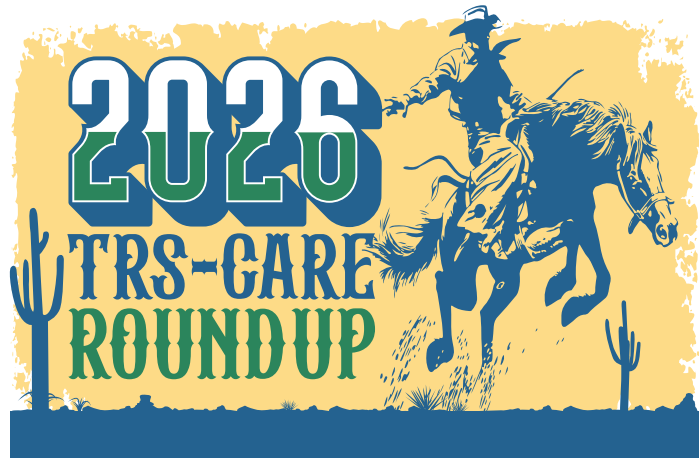

*TRS-Care reduces premiums for retirees with disabled children (regardless of the disabled child’s age) by \$200 in tiers with covered children.

TRS-Care Dental and Vision premiums will stay the same in 2026! Open enrollment for TRS-Care Dental and TRS-Care Vision for the 2026 plan year is Oct. 1 – Dec. 8, 2025. If you’re enrolling for the first time, you can **enroll yourself and your dependents in less than five minutes** through **MyTRS.texas.gov**! If you’re already enrolled, you don’t need to do a thing — unless you want to add eligible dependents. If you are adding eligible dependents, you can download and complete the application at **MyTRS.texas.gov** or call TRS Health at **1-888-237-6762** to get an application.
