# **Your Annual Statement Is Ready**

It's the most wonderful time of the year – time for you to receive your TRS annual statement! This is one of the most important documents you will receive from TRS. It includes your membership information and can be helpful in planning your future retirement.

All statements were sent by mail or electronically (if you have a MyTRS account) before Dec. 1, 2025. If your friend receives theirs before or after you do, don't worry; statements were made available in batches throughout October and November to all TRS members. As long as you have not retired or refunded your account, you should receive a statement.


Use MyTRS to view, download and print a copy of your statement at any time. All you need to do is log in and navigate to your Document Center. If you haven't already set up your MyTRS account, this is the perfect time.

#### Information on Your Statement

Retirement estimates are available to help you plan for retirement. You will find an unaudited retirement estimate based on your current years of service and the date you are first eligible to retire. We've also included a projection of service credit in which we assume that you continue to work until your retirement eligibility date.

The projected lifetime annuity value can help you understand the value of your potential retirement benefit. It represents the total amount you could expect to receive if you live to your normal life expectancy. It's important to note that this is not a guaranteed amount.

Review your statement and notify TRS immediately if information is incorrect regarding compensation or years of service credit. You may have an opportunity to have corrections made for the 2024-25 school year without having to pay additional cost other than the member contributions due on the compensation that was paid to you. TRS must be notified by May 31, 2026, so that the error can be corrected by the end of the 2025-26 school year.

New to TRS? If you recently became a new member of TRS or returned to TRS-covered employment after the end of the 2024-25 school year, you will not receive an annual statement until fall 2026.

# **Opening in 2055: The TRS Time Capsule**

TRS celebrated the installation of the TRS Time Capsule in September, highlighting the evolution and achievements of TRS and its members, while also serving as a tribute to the legacy and future of Texas public educators.

The capsule will be opened and explored by TRS members, retirees, staff and agency friends in 2055. It was designed to be reopened after 30 years, representing a full career's worth of impact and service.

TRS members, retirees and employees provided suggestions for items to be placed in the time capsule.



The selected items highlight moments from TRS history, such as an annuity payment wheel (at left), a tool that was used to determine a member's annuity payment at their retirement. Historical photos also show how TRS operated using the technologies of the time period. While many things



at TRS have changed, one thing has remained the same over time: A dedication to serving TRS members.

"We were a mission-driven organization in 1937 when we were created, we're a mission-driven organization now, and we will be 30 years from now," said Executive Director Brian Guthrie. "It's all about our members. And that will never change."



### To Use the TRS Employer Map

- 1. Go to the TRS website.
- 2. Navigate to **Pension Benefits** on the menu, then **Know Your Benefits.**
- 3. Click on the **Find a TRS-Covered Employer** button, then filter your search to look for employers.
- 4. Once you've moved, make sure to update your new address! You can do so by logging in to MyTRS.

# **New Financial Reports**

TRS recently published its **Annual Comprehensive** Financial Report (ACFR) for the fiscal year ending Aug. 31, 2025. It provides an overview of TRS' financial position, investment performance, membership statistics, and funding status. This document conforms with Governmental Accounting Standards Board (GASB) requirements and is audited by the state auditor.

TRS also published the Popular Annual Financial Report (PAFR), which highlights crucial financial information in a simplified and engaging summary compared to the more detailed ACFR. This summary features easy-to-read charts, graphs and other key information relating to the TRS pension fund and health care programs. To view the full reports, look for them on the **Publications** page of the TRS website located under the **Learning** tab.

# When Your **Personal Data** is Breached



If you are notified by an entity that your personally identifiable information (PII) has been breached, take these next steps. First, change passwords for affected accounts and enable two-factor authentication. Next, contact your bank and credit card companies to monitor suspicious activity and consider placing a fraud alert or credit freeze with credit bureaus.

If you have been offered credit monitoring as a result of the breach, sign up for it. Regularly check your account statements and credit reports for unauthorized transactions. Finally, be cautious of phishing attempts and scams targeting recent breach victims and contact your credit card issuer at the number on the back of your card.

Make sure to call your bank directly instead of responding to a text or a call you did not initiate. Taking these steps can help protect your identity and minimize potential harm.



### **How to Access Your Member Information**

Do you have questions about your own member pension records? You may want to find out your account balance, years of TRS service credit or TRS membership tier. It's your information, get it in the way that is best for you! Here are three options to help answer your questions:

#### **MyTRS** Member Portal

Log in to your TRS account 24/7 to view your information and make updates. This online resource allows you to explore your benefits, schedule counselor appointments, communicate with TRS and keep track of your personal account.

#### **Your TRS Annual Statement**

Your statement includes valuable information about your membership, such as salary and service credit, beneficiary information and your retirement estimate.

TRS mailed out annual statements in October, and your document is also available to view on MyTRS.

# Al: The New Face of Everyday Technology

Artificial intelligence (AI) isn't science fiction anymore — it's becoming part of our everyday work. But behind the buzzwords lies a simple truth: AI works best when people stay at the center. While AI technology will continue to evolve, the heart of TRS' mission stays the same: To serve with integrity, accuracy and care.

Across public service agencies, AI is becoming a helpful assistant. For many of us, AI represents another turning point in the long evolution of work. Just as email replaced memos and spreadsheets replaced ledgers, AI will become another everyday tool. But human oversight will always be essential. The best results come from a partnership: Technology plus human judgment.

#### **When Smart Tech Meets Smart Scams**

As Al becomes more sophisticated, so do the scams that use it. Cybercriminals are now leveraging the same powerful tools that legitimate organizations use — generating emails, messages and even phone calls that sound eerily real.

Where we once looked for typos or poor grammar as warning signs, AI can now create polished, convincing

messages that appear to come from coworkers, supervisors or familiar institutions. Some tools can even mimic voices or generate "deepfake" videos designed to trick people into sharing sensitive information or approving fraudulent transactions.

Remember, TRS **will not** reach out to you to ask for your personal information, your password, your banking details or to request any changes to your account. Be especially cautious when clicking on a link in an email that invokes TRS, even if the email looks legitimate. Go straight to the <u>TRS website</u> to access the <u>MyTRS</u> member portal.

If you are unsure about any message, always call TRS to verify if what you have received is a true communication from our agency.

# **Meet With Us All Across Texas**

TRS offers several ways to plan for your retirement by meeting with a TRS benefits counselor. Whether you prefer to attend in person or watch a virtual presentation, you can easily get the information you need. View our <u>Event Calendar</u> to sign up for upcoming benefits presentations and sessions.

**In-Person Counseling (Austin or El Paso):** About 10-12 months prior to retirement, meet one-on-one with a benefits counselor to review your retirement estimate. Appointments are available Monday through Friday.

**Virtual Counseling:** Meet with us by video or by phone! All you need is a personal computer or tablet with a camera, a reliable internet connection, and a quiet, private place.

**Retirement Forms Sessions:** Virtual forms sessions help members complete their retirement forms. These sessions are typically held on Wednesdays and Saturdays (retirement packet needed).

**Retirement Benefit Presentations:** TRS offers inperson presentations to groups in several cities across the state. Learn about retirement eligibility, tiers, calculation of benefits, retirement plans, death benefits, employment after retirement, and insurance.



**Virtual Retirement Benefit Presentations:** TRS offers virtual benefit presentations for members to attend during different stages of their careers: Intro to TRS, Mid-Career, and Ready to Retire.

**Field Office Visits:** If you are an active member considering retirement in the current school year, consider a one-hour one-on-one counseling session. These are held in several cities across the state.

**Group Office Visits at TRS (Austin):** Limited to 20 members who are considering retirement on or before January of the following year.

**Walk-Ins:** Walk-ins are for general questions or to drop off forms only. If more than 10-15 minutes are needed to discuss benefits, please schedule an appointment through **MyTRS** or by calling 1-800-223-8778.
