#### **Benefits**

Trustees approved benefit enhancements for some retirees as outlined in Senate Bill 10. The chief benefit officer also presented trustees an engaging by-the-numbers presentation.

- 510,091 phone calls
- 11,208 office visits (1,457 walk-ins)
- 17,102 retirements
- \$1 billion+ in monthly payroll to annuitants (\$5 billion+ in benefits paid)

#### Health

Health's presentation centered on the theme of Health Plan efficiency and cost savings. Trustees also approved deductible increases to TRS-Care Standard participants (for members under age 65)—the first in five years. Also, check out audit results for TRS' Medical and Pharmacy Program and Rebate Program (see from page 24 of the book).

Trustees also approved a two-year renewal of **Dr. Alice Cox** to the pension's medical board. The board is made up of a three-member panel of physicians who review all medical examinations as required by law. The panel also investigates essential statements and certifications regarding members of TRS who file disability retirement applications.

#### Investment Management

The chief investment officer provided his quarterly update. The pension trust fund's market value was at **\$185.4 billion** as of March 31, 2023. That represents **\$6.7 billion** in investment earnings **since January**.

The pension trust fund's investment consultant reported the pension fund's return for the first quarter of the year was **3.7%**. The three-year marker is **10.3%**, well above the current assumed annualized rate of return of 7% (That's the targeted average return trustees approved to ensure the fund stays healthy).

July's board meeting represents ample annual reporting from various IMD groups, and this year was no exception. The IMC Board Book features reports from:
