The committee shall: (1) hold public hearings on group coverage; (2) recommend to the TRS Board of Trustees minimum standards and features of a plan under the group program that that committee considers appropriate; and (3) recommend to the TRS Board of Trustees desirable changes in rules and legislation affecting TRS-Care. (See Sec. 1575.406 Insurance Code)
