We're happy to announce that TRS-Care Medicare rates and benefits will stay the same in 2024.

What's New?

TRS-Care has a new pharmacy benefits manager (PBM)! Express Scripts will be the new PBM for TRS-Care Medicare Rx. The new contract will generate savings to help sustain health care benefits for retirees and their families. Express Scripts will start administering pharmacy benefits on Jan. 1, 2024. SilverScript will continue to serve TRS-Care through Dec. 31, 2023.

We're also excited to announce that **dental and vision benefits for TRS retirees and their families are coming to TRS-Care in 2025!** The 88th Texas Legislature passed Senate Bill 1854, which allows TRS to **offer optional dental and vision care coverage** for TRS retirees. This includes their dependents, surviving spouses and surviving dependent children. In the coming year, we'll communicate when TRS retirees may enroll. **Coverage will start Jan. 1, 2025.**
